

# Boys & Girls Clubs of Thurston County Key Personnel Qualifications, Roles and Bios

### **Qualifications and Roles**

Key personnel at the Boys & Girls Clubs of Thurston County (BGCTC) Clubs are helping put young people on the path to great futures. With their collective belief that helping youth today means they'll approach adulthood stronger and more capable, BGCTC staff help youth foster positive relationships with caring adults and connections to new friends in a positive environment, reinforcing a sense of belonging, personal accountability, civility, and civic responsibility. Each member of our staff is proud to be part of a generation-changing program that supports a commitment to learning, positive values, healthy habits, and high expectations for success as an adult.

The BGCTC **CEO** leads the organization in all facets of operation, fundraising and strategic direction; is the face of the organization in the community; and supports both Board and staff teams in order to oversee the implementation of the mission of the organization.

BGCTC's **Chief Operating Officer** provides leadership to all Thurston County Clubs in the areas of professional development, program quality and efficiency, and parent/community relations. Shellica is responsible for ensuring that Club staff receive appropriate training and support, programs operate with a focus on quality and impact and facilities are safe and welcoming for Club members.

BGCTC's **Director of Finance & Administration** manages the daily financial and banking functions for the entire organization. In addition, with the Chief Executive Officer and Chief Operating Officer, the Director of Finance assists in developing the full-year budget and produces monthly financial statements for administrative and Board of Directors review.

BGCTC **Branch Directors** manage the overall daily operations of their respective Club with the primary concern for programs and service delivery to youth, supervision and training of staff, facilities management, community relations and member administration. Essential responsibilities for each of the branch directors include providing leadership, strategic planning, resource management, partnership management, and marketing.

# Chris Woods, CEO

Chris Woods, long-serving Thurston County educator and school administrator, was named CEO of Boys and Girls Clubs of Thurston County in April 2019. He brought to the position a long history of commitment to youth and community collaboration through his experiences as teacher, principal, coach, and school administrator.

In his short time serving the Boys & Girls Clubs, Woods helped facilitate the addition of two new Club branches to the organization: Yelm and a location at the Raj Manhas Activity Center ("RMAC branch"), bringing the number of Club locations in Thurston County to seven. His experience in education and as a life-long resident of Thurston County has strengthened partnerships with county school districts and community partners to maximize efforts to support youth academically, socially, and emotionally during the pandemic and remote learning.

Despite the challenges brought about by the COVID-19 pandemic, Boys & Girls Clubs in Thurston County remained open. They were **among 13% of Clubs nationwide who kept their doors open** throughout mandatory school closures. Initially serving first-responders and essential workers, the Clubs then opened enrollment following Department of Heath guidelines regarding capacity and safety. When the organization's budgeting model turned upside down with a move to full-day programming, Woods and his team continued to steward supporters and donors to continue investing in Boys & Girls Clubs of Thurston County.

As Woods looks to the future of the organization, his goal is to equip the organization with a diverse and sustainable revenue stream, high quality facilities for children and staff, expansion of services to include social, emotional, and mental health support, and continue to build on the strong and collaborative partnerships with all school districts in Thurston County.

Woods earned a B.A. degree from Central Washington University in K-8 Elementary Education and K-12 Special Education and prior to his position as CEO of Boys & Girls Clubs of Thurston County, he served as Assistant Superintendent for the Tumwater School District. Woods' credentials also include an M.A. in School Administration and Principal Certification from City University and Superintendent Certification from Seattle Pacific University.

He has served as a board member for the Briggs YMCA and Big Brothers Big Sisters of Western Washington; a coach with Thurston County Youth Football League, South Sound Baseball, and the YMCA; and a volunteer with Greater Olympia Young Life and West Olympia Rotary.

# **Shellica Trevino, Chief Operating Officer**

2020 marks the 19<sup>th</sup> year of Shellica Trevino's tireless Boys & Girls Club career in which she held a range of positions: Front Desk Receptionist, Social Recreation Coordinator, Membership Manager, Branch Director, Acting Executive Director, and, most recently, BGCTC's Director of Operations. Her tenure at various Clubs provided opportunities to hone her talent at professional development, program quality, parent and school relations and mentorship. Shellica shares how the challenges she and her family faced in her childhood revealed generosity and compassion by others. She believes the Clubs can serve a similar purpose for families that may be facing tough times. In 2013, Shellica received the Maytag Dependable Leader Award honoring her commitment to Boys & Girls Clubs, her impact on the lives of youth and the leadership shown in serving youth and the Clubs.
